All electrical equipment is assessed under the Portable Appliance Testing Regulations.

Trips 1	Band members, guests and members of the public through tripping over wires and cables placed by the band	When the band set up all wires are run around the back of the band to limit the likelihood of personnel walking over them. Cables and wires to the front side of the stage are positioned behind monitor speakers and under mic stands. Where wires pass over walkways and performance areas they are fixed every 40cm to the floor using Gaffa Tape	All band members are re-briefed about the need to manage the cables used when setting up the band. The use of cable ties for coils of wire/cable are provided and should be used to keep cables tidy where they are longer than required.	All band members	01/08/2016	01/08/2016
Trips 2	Band members, guests and members of the public through tripping over lighting, speakers and monitor cabinets	When equipment is positioned the equipment is positioned to limit the likelihood of trips and falls. Speakers, monitor cabinets and lighting are positioned in a defined "Front Line" which demarcates the "performance area" from the "public areas". Equipment is of significant size that members of the public can easily see them. Electrocution	Band members through the failure of equipment used during musical performances	All electrical equipment is PAT tested by competent members of the band. A log is kept of all equipment and each piece carries a label of Test. Mains power supplies are assessed by the band for suitability prior to use. The band uses a "Power Conditioner" to protect equipment from surges, spikes. This also trips following an fault and monitors the power supply to the band equipment	All wires used are fused to the correct rating. Power leads are inspected prior to use to ensure integrity is maintained. Any item found to be faulty prior to use is isolated from stock and either marked for repair or disposed of. Fire	Band Members through the failure of equipment provided by the band or from equipment provided by venues	All equipment is correctly fused and PAT tested. Therefore the risk of fire is greatly reduced. MP is trained to assess fire risk and take appropriate action as required	When the band performs in Marquees or temporary structures or where drapes or curtains are used an onsite assessment is conducted to ensure equipment cannot be brought into contact with such items throughout performances. Sets are restricted to a maximum of one hour each with breaks in between to allow for rest. Doors, windows and ventilation systems are expected to be employed when required.	If heat presents a significant risk to health, performance times will be reduce and more breaks inserted. If this does not prove effective performances may be cancelled. Where lifting is required two or more band members coordinate moving of equipment. MP is trained in manual lifting techniques and can asses situations. Vehicles will be supervised when manoeuvring in tight spaces and areas which vision is restricted	The use of cones or barriers may be necessary in certain situations. Security	Band members – the risk of assault or attack when loading or unloading equipment	When loading or unloading in areas that may present the risk of attack or assault a minimum of two band members will supervise the loading and unloading area. Assistance may be requested to the venue for additional supervision if it is deemed necessary.	Selection of a suitable location to unload will limit the risk of attack.
